



2026 Spring Riding Field Trial Red Rock Grounds May 15-17, 2026

This year, the German Shorthaired Pointer Club of Reno is conducting its Spring Riding Field Trial at the Red Rock Trial Grounds north of Reno, Nevada. Bring your water, shade, and chairs. Weather and temperatures vary significantly in the high desert, so note the area's forecasted weather before packing.

You may camp on the grounds, but sites are limited. **Please remember that the Reno/Sparks desert wilderness is arid. – NO SMOKING EXCEPT IN THE CAMP/PARKING AREA. NO OPEN FIRES, ETC. BE CAREFUL – carry extra water, shovel, and extinguisher in your vehicle. We trust you to respect the trial grounds.** No discharging of gray or black water; please leave the area clean.

Due to our continued drought, it's of the utmost importance to note that open flames, outdoor devices that use open flames, and smoking are strictly prohibited. Dry camping is allowed. Outdoor generators are allowed, but please clear the area around your generator. No motorized vehicles are allowed off designated roads.

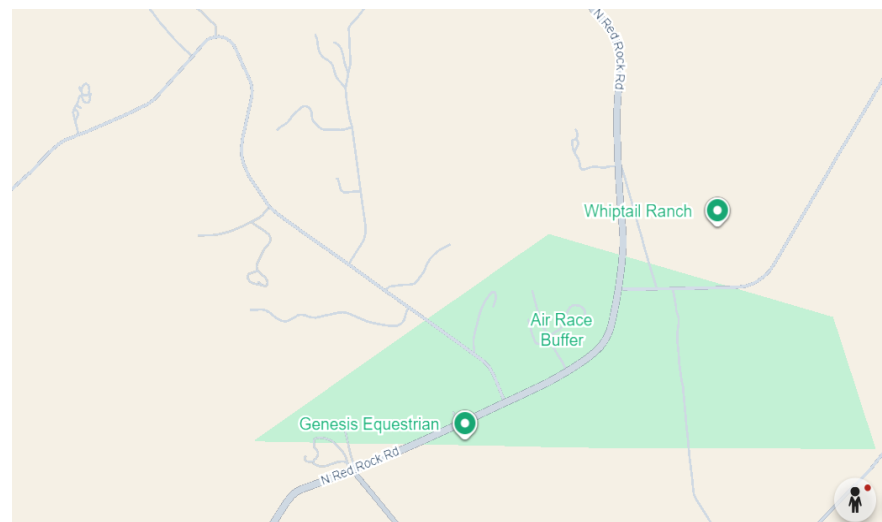

- From the I-80/US 395 interchange, head North on US 395
- Take Exit 78 – Red Rock Road, from the light at the Shell station, it is approximately. 7.3 miles to Columbia Hills Road. Please obey ALL speed limits
- Turn left on Columbia Hills Road, stay on the dirt road – speed limit is 25mph, the road can be heavily wash-boarded. From this turn off, it is approx. 2.1 miles to the cattle guard
- From the cattle guard, travel to the Lower Grounds, which is an open area near the Big Tree
- Parking, Camping, and Trial gathering will be here:

COURSE AND BIRDS

Single Course without Bird Field for all Stakes. Chukar and/or Quail will be released in all stakes **EXCEPT** the Open Puppy Stake. Blanks will not be fired in Puppy Stakes. Shotgun Blanks will NOT be permitted in any stake. AKC does not allow the use of pistols capable of firing live ammunition.

Open Gun Dog and Amateur Gun Dog are retrieving stakes, single course, blank all bird encounters, and call back for retrieve.

Open Limited Gun Dog, Amateur Limited Gun Dog, Open All-Age, and Open Derby are non-retrieving stakes on a single course. Blank all bird encounters.

NOTICES

This Trial will be run under the AKC Rules governing a Flexible Format. The Club reserves the right to rearrange the Running Order of the stakes and courses, and to rearrange judges if warranted by conditions. AKC-approved Tracking Collars will be permitted in all stakes.

Bitches in season may compete in the last brace of each stake. Horseback handling is permitted in all stakes.

PRIZES

Standard AKC rosettes to all placed dogs in each stake. The first-place dog in each stake will receive a trophy.
