Derby non-retrieving stake with single course and a Bird Field. Chukar and/or quail to be used in all stakes except puppy.

Directions to Red Rock Grounds:

From Reno Nevada take Highway 395 North.

Exit at Red Rock Rd and continue North about 8 miles and turn left on Columbia Hill Rd. This is a dirt road. Continue about 2 miles and cross cattle guard. At this point follow GSP signs for about another 3 miles on the left fork, then right through the fence and up the hill to the grounds.

Remember:

Bring folding chair, water and shade. There are no trees and weather may be hot. We will have some water but bring some for you and your dog. The closest place to get ice and supplies is where you turned off of highway 395 onto Red Rock Rd.

No open fires and remember to smoke in your car only.
